Below is a list of charges payable by water supply or sewerage licensees from 1st April 2023 to 31st March 2024. All requests should be sent by e-mail to tidworth.billing@veolia.com.

Other miscellaneous charges may also apply to Retailers where a non-primary service is requested by a water supply or sewerage licensee and VWPL has not published a rate for the service.

The rates are published in line with the requirements of the “Wholesale charging rules issued by the Water Services Regulation Authority under sections 66E and 117I of the Water Industry Act 1991” that are effective from April 2022.

Trade Effluent Consent Where the Company issues a full Consent for a Trade Effluent discharge. The following charge applies for activities involving risk assessment and administration.	£250

Definitions

“Non-Primary Charges” means any Wholesale Charges which are not Primary Charges and to avoid doubt this includes all charges that relate to the provision of one off or discrete services performed pursuant to the Operational Terms or as otherwise set out in the Wholesale Tariff Document in relation to specific circumstances or events.

“Non-standard activities” A quote will be provided for all requests classified as non-standard. Requests that include one or more of the following will be classified as non-standard:

- where the meter size is 30mm or greater
- requiring a road closure
- requiring notifications to third parties in advance of commencement of works
- requiring warrants for access
- for flow data that require a site visit to obtain
- where an additional charge is required for infrastructure (extra network demand)
- any activity not listed which requires disproportionate effort on the part of the wholesaler

“Primary Charges” and “Non-Primary Charges” mean those charges defined in the Market Operator Services Limited Wholesale-Retail Code Part 1: Objectives, Principles and Definitions.

“Standard” All of the charges listed as standard are for requests that will not require infrastructure modifications and are a fixed charge.

“Standard Hours” - 08:30 - 16:30 on weekdays (excl. Public Holidays).

Abortive visits
